4	<p><b>Police Scotland</b> – P.C. James Stewart is our new Community Support Officer. Chairman thanked him for his attendance. Reported following items In our area –</p> <p><b>Antisocial behaviour, Violence and Disorder:</b> On Thursday 24 January 2019 Police were advised of a disturbance within the Ordhead area. Following enquiries one male was arrested and charged with various anti-social behaviour offences.</p> <p>On the same day, Police were also advised of an indecent video that had been sent between Secondary School pupils who attend various schools within the local area. Enquiries are at an early stage at this time with several witnesses still to be traced.</p> <p><b>Road Safety &amp; road crime:</b> Yet again there have been numerous reports of Careless / Dangerous driving within the area.</p> <p>In January a male was charged with road traffic offences after his careless driving through Dunecht was captured on Dashcam.</p> <p>On Wednesday 23 January, several persons were taken to ARI (one with life threatening injuries) after a two vehicle collision on the A944. Enquiries continue with a report expected to be submitted to the PF in due course.</p> <p>On Wednesday 30 January a male was reported for Careless Driving after a two vehicle collision near to Tillyorn Cottage Echt.</p> <p>Hugh Falconer qualified that it was in order to share the Police reports on our web and facebook pages. <b>Action report to be posted as soon as possible and as an ongoing notification function.</b></p> <p>Additional police advice to be found on this report linked to wildlife crime and property security.</p> <p>Members of public from Midmar reported an incident of hare coursing.
