Frank Murray and Son to assist with risk assessment and installation.</p> <p><b>b.</b> Paradise Wood &amp; Tillyfourie Quarry damage etc. – Wild Life Officer looking to meet with concerned parties and Mac Walks to modify some of the online details that is impacting the area in a anti respectful behavioural way. Wild camping and fire raising remains a very real risk to these areas. Sir Archie Grant is examining creating a Paradise Wood circular path with parking and we can expect to see a planning application to remove aggregate from the bottom quarry at Tillyfourie.</p>	Info.
7	<p><b>Sauchen Issues –</b></p> <p><b>a.</b> Path to Cluny School – work progressing well. Walkers are already using the facility. The School Children have been given the opportunity to pick a path name we await to hear the outcome. It is vital that we now approach the Roads Dept. to consider the essential requirements to reduce the road speed to 30mph in this area.
